Conflict Material Statement

Virginia Panel Corporation has either obtained, or is in the process of obtaining, information based upon data provided by our suppliers, we do not knowingly use metals derived from the "Conflict Region" in our products.

On August 22, 2012, the U.S. Securities and Exchange Commission ("SEC") issued the final conflict minerals rule under Section 1502 the Dodd-Frank Wall Street Reform and Consumer Protection Act (the "Conflict Minerals Rule"). The Conflict Minerals Rule requires publicly traded companies to report annually the presence of conflict minerals (tin, tungsten, tantalum and gold, or "3TG") originating in the Democratic Republic of the Congo or adjoining countries ("Covered Countries").

Our Commitment

1. To support the aims and objectives of the U.S. legislation on the supply of "conflict minerals."
2. We will not knowingly procure specified metals that originate from the "Conflict Region" that are not certified as "Conflict Free."
3. Request that our suppliers perform reasonable due diligence with their supply chains to assure that specified metals are being sourced only from mines and smelters outside of the "Conflict Region" or mines and smelters which have been certified by an independent third party as "conflict free" if sourced within the "Conflict Region."
